Dr. Bhalchandra Blood Bank, Latur and represented herein by its Blood Transfusion officer (Hereinafter referred to as "Second Party"), (First Party and Second Party are here in after jointly referred to as 'Parties' and individually as 'Party') as

#### WHEREAS:

A) First Party is a Higher Educational Institution named:

Second Party is a Blood Bank named:

#### Dr. Bhalchandra Blood Bank, Latur

- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- Both Parties, being legal entities in themselves desire to sign this MOU for D) advancingtheir mutual interests.
- E) The second party will be engaged in Blood Donation, Blood Checkup, Blood Campaigning and other Extension Activities.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SETFORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

#### **CLAUSE 1:**

#### **CO-OPERATION**

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

First Party and Second Party in co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the changing scenario.

The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

## CLAUSE 2: SCOPE OF THE MOU

Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

- 1. The programmes like blood donation camp will be organized.
- 2. There will be exchange of information between two institutions regarding requirement of blood and available blood donor's among the students, faculties and citizens of the area.
- 3. Public awareness programs on importance of blood donation, nutrient diet with iron for

avoiding anemic conditions particularly among girl students and woman of the area will be organized jointly.

- 4. There will be exchange of faculties, students and other staff for the organization of various programs as per requirement.
- 5. Visit of student for acquiring information of the functioning of Blood Bank with all its technical and scientific aspects will be organized jointly as per convenience of both the parties.

Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the programmes on the terms specified herein

There is no financial commitment on both of the parties to take up any programmes mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

#### **CLAUSE 3:**

#### **INTELLECTUAL PROPERTY**

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

#### **CLAUSE4:**

#### **VALIDITY**

This Agreement will be valid for the period of **Five Years** until it is expressly terminated by either Party on mutually agreed terms and conditions. Both Parties may terminate this MoU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

#### **CLAUSE 5:**

### **RELATIONSHIP BETWEEN THE PARTIES**

5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party.
