## ACTIVITY REPORT

### Report on the workshop on Intellectual Property Rights in Pharmaceuticals conducted on 25<sup>th</sup> September 2018

#### Introduction

Intellectual property rights (IPR) have been defined as ideas, inventions, and creative expressions based on which there is a public willingness to bestow the status of property. IPR provide certain exclusive rights to the inventors or creators of that property, in order to enable them to reap commercial benefits from their creative efforts or reputation. There are several types of intellectual property protection like patent, copyright, trademark, etc.

More than any other technological area, drugs and pharmaceuticals match the description of globalization and need to have a strong IP system most closely. Competition in the global pharmaceutical industry is driven by scientific knowledge rather than manufacturing know-how and a company's success will be largely dependent on its R&D efforts. As product patents emerge as the main tools for protecting IP, the drug companies will have to shift their focus of R&D from development of new processes for producing known drugs towards development of a new drug molecule and new chemical entity (NCE). It is obvious that management of IP and IPR is a multidimensional task and calls for many different actions and strategies which need to be aligned with national laws and international treaties and practices. Since there exists the increased possibility that some IPR are invalid, antitrust law, therefore, needs to step in to ensure that invalid rights are not being unlawfully asserted to establish and maintain illegitimate, albeit limited, monopolies within the pharmaceutical industry.

#### Session Background

The session began with a welcome and felicitation of the guest following the inaugural session: the participants were introduced to the resource person with his brief introduction by *Mrs. Rajamanya T. M.* The sessions were spread over half day from 2.00 pm to 5:00 pm. Faculties. Staffs and students alike participated actively in the event. There were continuing discussions in between the lectures. The participants took keen interest in discussions and understanding the practical implications of good practices in patent filling. Concluding session ended with vote of thanks by Professor *Dr. Bhusnure O. G.* expecting more thoughts provoking sessions in upcoming times.

#### **Speaker Address**

*Mr. Vijaykumar Shivpuje, Ex-Assistant General Manager-IPR* spoke on the basic concepts of Intellectual Property Rights. IPR by itself neither helps nor hinders development necessarily. It is how laws, policies and practices are designed and used in different countries that determine whether IP is effective for development purposes.
