व्यावसायिक अभ्यासक्रमाचे शुल्क निश्चित करण्यासाठी शिक्षण शुल्क समिती अस्तित्वात असताना समितीच्या निर्देशानुसार तंत्र शिक्षण संचालनालयांतर्गत येणाऱ्या अभ्यासक्रमासाठी प्रथम वर्षाचे शुल्क मंजूर झाल्यानंतर शैक्षणिक वर्ष २०१२-२०१३ ते २०१५-१६ या शैक्षणिक वर्षामध्ये व्वितीय वर्षापासून ८ टक्के शुल्क वाढ देण्यात येऊन वाढीव शुल्क अभ्यासक्रम पूर्ण होईपर्यंत लागू होते. सदर वाढ ही शैक्षणिक तसेच विकासात्मक शुल्कामध्ये अपेक्षित होती. शैक्षणिक वर्ष २०१६-१७ पासून महाराष्ट्र विनाअनुदानित खाजगी व्यावसायिक शैक्षणिक संस्था (प्रवेश व शुल्क याचे विनियमन) अधिनियम, २०१५ नुसार शुल्क नियामक प्राधिकरण अस्तित्वात आल्यानंतर अधिनियमातील कलम १४ (६) नुसार शुल्क नियामक प्राधिकरणाने मान्य केलेले शुल्क त्या शैक्षणिक वर्षात त्या विनाअनुदानित संस्थेत प्रवेश घेणाऱ्या उमेदवारांच्या बाबतीत लागू असून संबंधित संस्थेतील अशा विद्यार्थ्यांचा अभ्यासक्रम पूर्ण होईपर्यंत तेच शुल्क लागू राहणार आहे.

2. आपले सरकार महाडीबीटी पोर्टलमध्ये संस्थांनी भरलेल्या शुल्काची पडताळणी करताना अनेक संस्थांनी तत्कालीन शिक्षण शुल्क समितीच्या निर्देशाप्रमाणे शैक्षणिक शुल्क तसेच विकासात्मक शुल्क यामध्ये शुल्क वाढ घेतलेली नाही. तत्कालीन समितीने / प्राधिकरणाने निर्धारीत केलेल्या शुल्कापेक्षा संस्थांनी भरलेले शुल्क कमी असल्यास सदर शुल्कास प्राधिकरणामार्फत मान्यता दर्शविण्यात आलेली आहे. तथापि, आता अनेक संस्था त्यांनी पोर्टलवर भरलेले शुल्क कमी अथवा चुकीचे असल्याने ते प्राधिकरणाने मार्ग घ्यावे (Revoke) अथवा नामंजूर करावे (Reject) अशी मार्गणी करीत आहेत. सद्य:स्थितीत शैक्षणिक वर्ष २०१८-१९ साठी संबंधित शिष्यवृत्ती योजनांसाठी विद्यार्थ्यांनी भरलेल्या ऑनलाईन अर्जाची संस्थाकडून छाननी करून विभागीय कार्यालयांकडून छाननी केलेले अर्ज तंत्र शिक्षण

Inthepresenceofa fees regulatory authority established for fixation of tuition fees ofthevocationalcourse, as per the opinion of FRA, fees fixed to all courses running under the Directorate of Technical Education in the academic year 2012-2013 to 2015-16, in the same academic year from second year onwards every year 8% rise applicable till the completion of the course. The said rise in fees was expected ineducational as well as development fees. From the academic year 2016-17 after the Fee Regulatory Authority came into existence under the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admission and Fees) Act, 2015, the fees approved by the Fee Regulatory Authority as per Section 14 (6) of the Act of the candidates taking admission in that unaided institution in that academic year as applicable, the same fees will remain applicable till the completion of the course of such students in the concerned institution.

2. While verifying the fees paid by the institutes in our government's MahaDBT portal, many institutes have not taken the fee hike in education fee as well as development fee as directed by the then Education Fee Committee. If the fee paid by the institutions is less than the fee fixed by the then committee/authority, the said fee has been approved by the authority. However, many organizations are now demanding that the authorities revoke or reject the fee they have paid on the portal as it is low or incorrect. Current Status: Online applications filled by students for respective scholarship schemes for the academic year 2018-19 have been scrutinized by the institution to the departmental offices and applications scrutinized by the departmental offices. The Directorate is

receiving and accordingly the process of preparing its online payment is underway and action has also been taken to distribute the benefits.

3. In view of the above fact, if the institution under Rajarshi Chhatrapati Shahu Maharaj Education Fee Scholarship Scheme in the academic year 2018-19 has not paid the tuition fee on the MahaDBT portal taking into account the increase of 8 percent due in the academic year 2016-17 as approved by the earlier Education Fee Committee, no change is permitted. The government has decided not to give. However, before disbursing the second installment of the scholarship, the institutes which have requested for the fee change are being given an opportunity to change the fee actually charged by the institute on the MahaDBT portal as per the verification from the Divisional Joint Director of Technical Education. Accordingly, the Director, Technical Education and Secretary, Fee Regulatory Authority should take further action.
